1.2. APPLICATION DATES

Within the scope of the "2023-1-TR01-KA171-HED-000164429" KA-171 Project Erasmus+ Incoming Study Mobility, applications of students who wish to benefit from the Erasmus+ Study Mobility will be accepted **between December 8 and December 22, 2025**, **via the e-mail**.

1.3. FOREIGN LANGUAGE REQUIREMENT

International exams recognized as equivalent by ÖSYM are accepted. During the application process, you will be required to upload a document proving that you have obtained a minimum score of 60 out of 100 from one of the English exams of PTE, TOEFL, Cambridge.

Within the scope of the KA-171 Project Erasmus+ Study Mobility, students who are awarded a grant may receive financial support for a maximum of one academic semester.

1.5. WHO CANNOT APPLY?

- 1. Students enrolled in departments **not listed in the table above** are not eligible to apply for the KA-171 Project Erasmus+ Study Mobility.
- 2. **Senior (final-year) students** cannot apply for the Erasmus+ Study Mobility.
- 3. Students cannot apply through their minor programs.
- 4. Students who are currently studying at our university through any other exchange program are not eligible to apply.





2. KA-171 PROJECT ERASMUS+ STUDY MOBILITY APPLICATION REQUIREMENTS

- 1. The applicant must be an **active student** enrolled in one of the programs specified above within the higher education institution.
- 2. The applicant must have a minimum Grade Point Average (GPA) of 2.20/4.00 for undergraduate students and 3.00/4.00 for master's and doctoral students.
- 3. The applicant must have a **sufficient number of ECTS credits**¹ available for the study mobility.
- 4. If the student has previously benefited from Erasmus+ or Lifelong Learning Programme (LLP) higher education student mobility activities within the same study cycle, the total duration (including the new activity) must not exceed 12 months.
- 5. Students who do not meet these criteria are **not eligible to apply**. Having failed courses from previous semesters **does not prevent** a student from applying for the KA-171 Project Erasmus+ Study Mobility.

¹According to the European Commission's ECTS Users' Guide, the sufficient number of credits for one academic year is **60 ECTS**. Even if selected, students **cannot participate** in the mobility if they do not complete **30 ECTS credits** for one semester at the host institution.





2.2. SPECIAL NOTES REGARDING APPLICATIONS FOR KA-171 PROJECT ERASMUS+ STUDY MOBILITY

Applications for the KA-171 Project Erasmus+ Study Mobility will be accepted **between December 8 and December 22, 2025**.

Even if selected, participation in the mobility **will not be possible** if **30 ECTS credits cannot be matched** at the host institution.

For study mobility, a sufficient number of ECTS credits must be available. For students **without** a full course load, such as those who have entered the thesis phase of master's or doctoral programs, a learning agreement can be arranged based on non-course workload equivalent to 30 ECTS for one academic semester.

ATTENTION:

If you are awarded mobility under the KA-171 Project Study Mobility Applications, you will be able to undertake your mobility in the Fall or Spring semester of the 2026/2027 academic year.

Important Notes for the KA-171 Project Erasmus+ Study Mobility Application Process

- Applications for the KA-171 Project Erasmus+ Study Mobility will be accepted between December 8 and December 22, 2025. Applications submitted after these dates will not be accepted under any circumstances.

- Students who submit an application incorrectly or incompletely will not have the right to modify their application afterward. Therefore, applicants must be careful when submitting their applications.
- Students who are selected but **decide not to participate** in the Erasmus mobility will be given a **deadline to notify their withdrawal**. If a withdrawal notification is **not submitted within this period**, **10 points will be deducted** from the student's score in any future Erasmus mobility applications.





3. EVALUATION CRITERIA

In the evaluation, 50% of the student's Cumulative Grade Point Average (CGPA) and 50% of the Foreign Language Score will be taken into account. The sum of these scores constitutes the final score (Erasmus+ Score).

According to the evaluation criteria specified below, a student must achieve a **minimum of 60 points** in the final score (Erasmus+ Score) to be considered **successful** for the KA-171 Project Erasmus+ Study Mobility.

The selection criteria and weighted scores to be used in the evaluation of applications are as follows:

5. MONTHLY GRANT AND TRAVEL ALLOWANCE

Students are provided with a **grant** to help cover additional expenses incurred during their time abroad. The grants are **not intended to cover all costs** related to the mobility activity, but rather to **contribute** to these expenses. In addition to the grant, students participating in the KA-171 Project Erasmus+ Study Mobility will receive a **travel allowance**, calculated based on the distance (kilometers) to the host institution. Students who wish may **opt out of financial support**.

5.2. ADDITIONAL GRANT SUPPORT

Within the KA-171 framework, **additional grant support** may be provided **only to students with disabilities** participating in incoming student mobility. The amounts of the additional grant are indicated in the table below.

Type of Mobility	Additional Grant Amount	
Student mobility of 2–12 months	€250 per month	
Short-term student mobility of 5–14 days	€100 in addition to the total daily grant	
Short-term student mobility of 15–30 days	€150 in addition to the total daily grant	

To verify whether a participant qualifies as a student with a disability, **official documents** issued by higher education institutions in accordance with national regulations (e.g., disability card, medical report) must be submitted.





5.3. SUPPORT FOR PARTICIPANTS WITH SPECIAL NEEDS

The Erasmus+ Program encourages the participation of individuals with **special needs**. A person with special needs is defined as a potential participant whose **physical, mental, or health condition** would prevent them from taking part in the project/mobility activity without **additional financial support**.

To enable students with disabilities to participate effectively in educational activities, **additional grants** may be provided within the scope of the Erasmus+ project.
