









Title: Understanding EU Policy for Equality

#### **Abstract:**

The UEUPE project contributed to increased knowledge and capacity of youth and academia on European standards of equality, tolerance, and accommodation of diversities through academic discourse and information-sharing via teaching/learning and research-oriented activities. thereby counteracting misconceptions about EU values. UEUPE was an academic response to existing challenges, aiming to transform the situation by filling in existing knowledge gaps and thereby counteracting misconceptions about the EU values by producing sustainable effects in the run. UEUP served primarily the TSU long academic community but also reached out to colleagues and students from other HEIs and targeted media professionals responsible for transferring information to the general public. Specific objectives of the Jean Monnet Chair included:



Upgraded curricula of BA and MA programmes of International Law at TSU to incorporate new/modified courses/topics related to Integration and equality policy with reference to minority rights protection in Georgia, and offered these courses to other law students and/or students of other disciplines (humanities, STEM). Created publications for disseminating information about related anti-discrimination standards: these included a research publication in the format of the book, "European Union and Protection of the Rights of the persons belonging to national minorities," used both as a didactic guide in Georgian language and as a reference book for interested public, along with the other information publications such as leaflets. brochures. and press releases. Increasing resilience to information manipulation, through increased awareness of relevant professional groups (media professionals/journalists) on equality (including hate speech related issue) and multiculturalism.

- Three updated syllabi on "Ethnic, Religious, and Linguistic Minority Standards under International, Universal, and Regional Law" (MA); "Religion and International Law" (BA) and "Role of ECRI in the protection of vulnerable groups"/ "ECRI in Georgia" (MA);
- Doctoral Seminar on the European standards for equality and combating hate speech;
- Public lectures/talks on EU Integration, equality and non-discrimination issues.



In line with the human rights milestones, the activities offered by the proposed Jean Monnet Chair on "Understanding EU Policy for Equality" (UEUPE) seeks to contribute to improving the knowledge about the EU, and more importantly offer constructive academic discussion European values and the European Union Law particularities focused on equality, antidiscrimination, inclusion and multiculturalism standards of international Law aimed combating xenophobia and hate speech, with due regard to relevant EU law and standards and their relative influence on Georgia's legislation and practice.

## INTEGRATION OF JEAN MONNET CHAIR INTO INTERNATIONAL LAW INSTITUTE

On February 7, 2023, Board of the Faculty of Law at Tbilisi State University (TSU), acting on the recommendation of the Scientific Council of the International Law Institute, approved an updated statute for the International Law Institute.

updated statute is noteworthy for its inclusion of a provision about the establishment of the Jean Monet Chair under the umbrella of International Law Institute. establishment of this Chair within the International Law Institute signifies commitment to academic excellence and the advancement of legal scholarship.



# IMPLEMENTED ACTIVITIES

## Creation of new course -Human Rights and Diversity, Combating Discrimination and Hate Speech

The new course: "Human Rights and Diversity, Combating Discrimination and Hate Speech" was elaborated by the Chair and syllabus of the course was included to the newly accredited Program of International Law (February, 2021). In a spring of 2021 the same syllabus was presented to the faculty accreditation committee and faculty board, based on requirement procedures of the University, After the presentation the new course was unanimously by the committee and the board, approved Consequently the course has been offered to the Law program students since 2021/2022 academic year.


## Updating syllabuses on BA and MA subjects

### **Doctoral Thesis/Seminars**

PhD students had prepared comprehensive research papers on the intricate subject of EU law and standards, with a particular emphasis on the critical issues of equality and combating hate speech.

These research papers delved into the complexities of the legal framework, dissecting the various aspects of EU law that pertain to equality and the fight against hate speech. The students meticulously analyzed the existing legislation, case law, and academic literature, aiming to shed light on the current state of affairs and propose potential improvements.

Topics of the doctoral seminar thesises:

- 1.The role of international organizations monitoring system in the context of fulfillment the international obligations of the state;
- 2.Legal aspects of the correlation between international (universal/regional) standards of the protection of ethnic, linguistic and religious minorities and domestic legislation of Georgia;
- 3. Defending the ideals of freedom of expression and equality in the context of Covid 19;
- 4. National approaches of Western countries in response to "hate speech";
- 5.The influence of the EU Charter of Fundamental Rights on European Law;
- 6.The role of International organizations in promoting International Law;
- 7.Impact of the Judgments of the European Court of Human Rights and UN Treaty Bodies on Georgian Legislation and Practice:
- 8. Protection of Personal Data Under EU Charter of Fundamental Rights.



The Jean Monnet Chair project application did not explicitly mention the inclusion of PhD students; however, it has since welcomed two students into our PhD program. These individuals are currently working on theses that align with the project's objectives:

- Impact of EU Law on the Georgian National Legal System
- Theoretical and Practical Aspects of the Rule of Law under Article 2 of the TEU

These additions to the program underscore the project's commitment to fostering academic growth and research in areas pertinent to its mission.



### **Trainings for Journalists**

A training module developed on EU standards of equality, multiculturalism, and addressing hate speech for the training of journalists was developed. The training module methodology was tailored to fit the interests of the specific target group, and it consisted of 10 sessions. These sessions covered various aspects, including legal concepts, applicable terminology, and specific cases of individual and organizational success stories that showcased EU support and its positive impact. The training module addressed key points, such as the challenges media faced when dealing with EUrelated issues, reporting on European Union values related to antidiscrimination regulations, and how to measure freedom of speech and handle hate speech. Role-play scenarios were elaborated for training, focusing on challenges in covering EU-related issues in media and pitching EU stories to skeptical audiences. The training aimed to increase participants' knowledge of EU-Georgia relations, promote quality journalism, and provide media professionals with tools to recognize the fundamental rights angle during news coverage.

The training sessions were carried out in partnership with Media Voice, a renowned Georgian NGO dedicated to promoting media freedom. With Media Voice training sessions were conducted in 5 different regions of Georgia:

- 1. Tbilisi;
- 2. Adjara;
- 3. Samtskhe Javakheti:
- 4. Kakheti;
- 5. Shida Kartli;

For each training session, journalists from both the national and regional levels were carefully selected, and the sessions were designed to span 1.5 days. The training sessions utilized a variety of instruments and methods to ensure their effectiveness. These included interactive workshops, multimedia presentations, group discussions, case studies, role-play exercises, and expert-led lectures.



These diverse tools were employed to engage participants, enhance their understanding, and facilitate practical skill development during the training sessions. 

#### **Student Conferences**

The project also envisioned conducting student-targeted activities, including a student conference, for which participants were selected through a strict procedure. These activities help deepen the interest of young people in the fields of European Union Law and EU-Georgia relations studies and stimulate future autonomous student activities in this direction. To enhance the visibility of the project's student-targeted results, selected student works were published on Google Drive online, while the best seminar and conference contributions were submitted to the (Georgian) Journal of International Law.

 On August 3, 2022, a scientific conference of students "Modern challenges of international migration processes" was held in online format.

Papers for the conference where prepared with supervising of assistant-professor Mariam Kevlishvili, from which 16 best were selected.

The high qualified expert-evaluators where invited from relevant stake-holders, such as: Ministry of Internal Affairs of Georgia, Ministry of Justice of Georgia, Ministry of Internally Displaced Persons from the Occupied Territories, Labor, Health and Social Affairs of Georgia.


The participants of the conference received positive evaluations from experts in the field and noted the diversity of the presented issues. There were also named 5 best papers/speakers.




## Discussions with colleagues


