The Embassy of Switzerland presents its compliments to the Ministry of Foreign Affairs of Georgia and has the honor to inform the Ministry that Georgian nationals are eligible candidates for the Master of Advanced Studies in European and International Governance (MEIG Programme) offered by the University of Geneva in cooperation with the United Nations Office at Geneva.

The Embassy further would like to inform the Ministry that the MEIG Programme aims at transferring knowledge about European and international governance as well as to provide participants with the essential professional skills to become a leader in this specific field. There are a few scholarships available for nationals from Official Development Assistant (ODA) recipient Countries, which includes Georgian Nationals. The Embassy also underlines that the next edition of the MEIG Programme will run during the 2024-2025 academic year, to begin in September 2024. There are three deadlines for application to the Programme:

First Deadline:

15 November 2023

Second Deadline:

31 December 2023

Third Deadline:

15 February 2024

Applications from candidates who apply for a scholarship must be filed before the First Deadline on 15 November 2023.

Bourses pour des participants du « Master of Advanced Studies in European and International Governance » de l'Université de Genève

Madame l'Ambassadrice, Monsieur l'Ambassadeur,

Permettez-moi de vous écrire à propos de la prochaine édition du « Master of Advanced Studies in European and International Governance, (MEIG Programme) » organisé par l'Université de Genève en coopération avec l'Office des Nations Unies à Genève.

Le programme combine des études académiques et une formation pratique, suivie d'un stage dans une organisation internationale ou d'une étude approfondie sur un thème en lien avec la gouvernance. Ce programme de 10 mois s'adresse particulièrement à des jeunes professionnels ayant déjà une expérience pratique et souhaitant parfaire leurs connaissances en gouvernance européenne et internationale. Des informations détaillées sur le MEIG sont consultables sur notre page internet : www.meig.ch.

L'excellence de ce programme a convaincu des donateurs privés d'offrir quelques **bourses pour des participants du MEIG** venant de pays bénéficiaires de l'APD selon la liste établie par le CAD/OCDE. La raison principale est que la coopération internationale ne peut réussir que si les acteurs qui y participent ont de bonnes connaissances du fonctionnement de la gouvernance internationale. Nous disposons de **quelques bourses d'un montant de CHF 45'000.-**. Elles couvrent les frais d'inscription et apportent une contribution substantielle aux coûts de la vie à Genève. Les **autres bourses, chacune d'un montant de CHF 20'000.-**, constituent uniquement une contribution aux coûts de la vie à Genève. Les deux catégories de bourses sont réservées à d'excellents candidats qui ne disposent pas des moyens financiers pour couvrir les frais liés au programme. L'attribution de ces bourses est





conditionnée par le fait que les récipiendaires s'engagent à rentrer dans leurs pays respectifs afin de les faire bénéficier des compétences acquises au cours du programme. Les candidats sont également tenus de participer activement et d'assister aux cours à l'Université de Genève du premier au dernier jour du programme. Si ces conditions ne sont pas respectées, le récipiendaire devra rembourser l'intégralité de la bourse.

Madame l'Ambassadrice, Monsieur l'Ambassadeur, vous êtes les mieux placés pour partager cette information avec de potentiels participants. Il peut s'agir par exemple d'un collaborateur dans un Ministère, y compris des affaires étrangères, de jeunes professionnels travaillant dans le secteur privé ou dans une organisation non-gouvernementale ou d'excellents étudiants de niveau master. Les autres conditions d'admission au programme sont indiquées sur le site internet du MEIG (www.meig.ch). La sélection des candidats se fera sur dossier.

Je m'adresse à vous car le MEIG Programme contribue aussi à renforcer et faire rayonner la Genève internationale ce qui est une des priorités de notre politique étrangère. N'est-il pas dans l'intérêt de la Suisse que de futurs dirigeants connaissent la Genève internationale ? Evidemment notre programme est également ouvert aux personnes n'ayant pas besoin de bourse. Nous vous serions donc reconnaissants de bien vouloir également faire circuler l'information sur le MEIG Programme auprès d'autres institutions intéressées, universités ou autres entités aussi bien du secteur public que du secteur privé.

La prochaine édition du programme (année académique 2024-2025) débutera en septembre 2024. Les candidatures pour l'admission au programme et pour l'attribution des bourses doivent nous parvenir avant le 15 novembre 2023.

Vous trouverez, en annexe, le flyer du programme, le formulaire de candidature au MEIG ainsi que le formulaire pour la demande de bourse. Je joins également un exemple de note verbale qui pourrait faciliter la diffusion de l'information, si nécessaire.

Thank you for applying for admission to the Master of Advanced Studies in European and International Governance (MEIG Programme). We are aware that the costs related to our programme, in addition to the living costs in Switzerland, are high, especially in the current economic context. While our programme does not have sufficient funds to offer scholarships, be assured that we make every effort to solicit support from external sources. We have been able to secure a number of scholarships from a local sponsor. These scholarships cover mainly the tuition fees. We may also be able to arrange for partial scholarships towards living expenses during the programme.

Our sponsor has established strict eligibility criteria:

- Demonstrated financial need on the part of candidates as well as their immediate and extended families, employers and any other persons who might otherwise have been able to contribute toward financing their studies;
- Failure to secure loans or scholarships from all other available sources, including employers, banks, governments and private providers.


